PLEASE NOTE: When ordering for a group, SEND ONE ORDER FORM AND ONE CHECK. Ticket orders will be filled in the order of the random drawing done on December 5, 2022. All tickets for each session are for specific seats for that session. Tickets for the two Thursday sessions and the two early Friday sessions are \$8. Some seats are in the preferred seating areas for Friday Night Semifinals and Saturday, some are not, but are in the Upper Bowl End Zones. Preferred seats for those two sessions are \$10; Upper Bowl End Zone seats for those two sessions are \$8. All of the tickets needed to attend the Wrestling Championship may be purchased by using this form. Check or money order, plus \$6.50 CHI Health Center Omaha handling fee, must accompany ticket orders. No refunds will be made on tickets. Mail orders will not be filled after January 2, 2023.

Instructions for accessing and transferring tickets for 2023 NSAA State Wrestling

Accessing Tickets:

The link to access your NSAA State Wrestling tickets is <https://am.ticketmaster.com/chi/#/>. The email address associated with your account is the email address you have put on the Ticket Order Form

If you don't already have an account setup, once you enter the site, you will need to click "sign in" (located in the upper right-hand corner) and then click sign up where it says, "new to Ticketmaster?"

Once your account is set up, you will have access to your tickets.

Please note, tickets can only be accessed by using the link above; they cannot be accessed through Ticketmaster.com or the Ticketmaster app. We recommend uploading your tickets into your digital wallet or you can bookmark <https://am.ticketmaster.com/chi/#/>.

Transferring Tickets:

We highly recommend sharing the above instructions to anyone you may transfer tickets to.

When tickets are transferred, the recipient will receive an email letting them know to accept the transfer. The recipient will follow the link and log in or create an account with the email address the tickets were sent to. If tickets to multiple events were sent, there will be a separate email to accept each.

If the recipient already has a Ticketmaster account, they can use the same login information; however, they will only be able to view their tickets for NSAA State wrestling at <https://am.ticketmaster.com/chi/#/>.
